In 2017 to 2018, our disaster recovery team removed a total of 30,000 "leaners" and 75,000 "hangers" during Hurricane Irma in Florida and 28,000 "leaners" and 62,000 "hangers" in Puerto Rico after Hurricane Maria in very challenging and hilly conditions.
